## POSITION DESCRIPTION

TITLE: SCHOOL ASSISTANT/TRANSPORTATION

TYPE: Classified

REPORTS TO: Director of Transportation

### POSITION SUMMARY:

The primary purpose of this position is to provide transportation with various student supervision and assistance tasks as directed by the director of transportation. Supervision and monitoring tasks shall include bus area, buses, or other school areas. In some cases, supervision may occur away from the school, such as on field trips. Other responsibilities may include light housekeeping duties and safety inspection and monitoring of the buses.

### MINIMUM QUALIFICATIONS:

1. High school diploma or equivalent.
2. Criminal history clearance.
3. Demonstrated basic skills through a local academic assessment.

### ESSENTIAL FUNCTIONS:

1. Assists the designated bus driver(s) with individual supervision and behavior management of students on the bus.
2. Observes, collects data, and records student behavior.
3. Performs bus area, bus, and general school supervision.
4. Prepares and operates audio-visual equipment as needed.
5. Performs clerical activities as needed.
6. Participates in staffing or parent meetings as directed.
7. Assists parents and community members as needed.
8. Participates in district classified assistant staff development program activities.
9. Works harmoniously with others and communicates effectively (both orally and in writing) with students, parents, and staff.
10. Frequent and prolonged talking/hearing conversations.

**OTHER REQUIREMENTS:**

1. Possible exposure to bodily fluids due to student or employee illness or injury.
2. Work is both indoors in school buildings, outdoors on playgrounds and school grounds, and occasionally on district vehicles and away from the school site.
3. May be required to obtain a First Aid and/or CPR Card and serve as a Delegated Caregiver or Designated First Aid Provider.
4. Occasionally performs other duties as required by supervisor.

**WORKPLACE EXPECTATIONS:**

The employee has regular attendance at work and work activities, and is punctual in meeting deadlines, attending meetings, and following schedules.

The employee is dressed and groomed in a neat, clean, and appropriate professional manner for the assignment and work setting.

The employee maintains the integrity of confidential information relating to a student, family, colleague, or district patron. The employee uses or relays personal information only in the course of performing assigned responsibilities and in the best interest of the individuals involved.

The employee follows all district or supervisor policies, rules, regulations, memos, bulletins, announcements, applicable position descriptions, and reasonable requests by proper authority.

**TERMS OF EMPLOYMENT:**

Current work year of approximately 180 paid days subject to change.

Salary and benefits based on current District Salary Schedule and negotiated agreement.

**EVALUATION:**

Performance in this position will be evaluated in accordance with District policy and regulations concerning personnel evaluation.
